Charge: Breach of Conditional Sentence Order

Released:

- Bail hearing on November 8th
- Released on a Form 11
- Report to Probation as directed
- Next court date is December 2nd



Charges: Possess schedule I substance x 4, Breach Probation x 2

Released:

- Bail hearing on November 10th
- Released on a Form 11
- Notify STPS of his address within 24 hours of any change
- No contact/communication in any way with the named party
- Don't attend their home, work, school
- Do not possess any weapons
- Next court date is December 1st



Charges: Theft under, Food & Lodging fraud, Assault with a weapon,
Possess weapon dangerous to the public, Utter threats, FTC x 3

Released:

- Bail hearing on November 12th
- Released on a Form 11; Promise to \$1000 if FTC
- Charges withdrawn by the Crown; Theft under, Utter threats, B&E, FTC
No public interest
- Report to the John Howard Society as directed
- Do not attend the named locations and addresses
- Do not contact/communicate in any way with all named parties
- Do not attend their home, work, school
- Do not possess any weapons
- Next court date is December 3, 2025

Charges: Impaired operation, Possess Fentanyl, Theft under x 3,
FTC Probation x 4, FTC undertaking, Possess property over \$5000,
Possess property under \$5000

Released:

- Bail hearing on November 13th
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Do not contact/communicate in any way with the named party
- Don't be within 50m of their home, work, school, incl. named address
- Do not operate or have care/control of a m/v
- Next court date is December 8th

Dispositions:



Charges: Pointing a firearm, Utter death threat, FTC

Disposition:

- Court appearance on November 12th
- Guilty pleas; Utter death threat, FTC
- 18 months' Probation
- No contact/communication in any way with the named parties
- Do not attend their, home, work, school
- Do not possess any weapons
- Perform 50 hours of community service



Charge: Mischief under \$5000

Disposition:

- Court appearance on November 12th
- Charge withdrawn by the Crown
- File is 42 months old

Charge: Assault – Spousal x 2

Disposition:

- Court appearance on November 12th
- Guilty plea to Assault
- Absolute discharge
- Remaining charge was withdrawn as per the resolution



Charge: Assault - BH

Disposition:

- Court appearance on November 12th
- Charge withdrawn by the Crown
- No reasonable prospect of conviction – NRPC



Charge: Assault – Spousal x 2, Criminal harassment, FTC x 6

Disposition:

- Court appearance on November 12th
- The Crown stayed the following charges; Assault x 2, FTC x 2
- Remaining charges were withdrawn



Charge: Impaired operation – Over 80 BAC

Disposition:

- Court appearance on November 14th
- Guilty plea to lesser offence of Careless driving
- \$1000 fine, 12 months' POA Probation
- Complete remedial training
- Zero BAC while operating a m/v
