- Do not contact/communicate in any way direct/indirect with the named parties

- Guilty plea to FTC with Prohibition re: children
- Time served; 79 days PSC enhanced to 119 days
- Remaining charge was withdrawn



Charges: Assault, Utter threats

Disposition:

- Court appearance on October 28th
- Guilty plea to assault
- 10 days of PSC enhanced to 15 days
- 12 months' Probation
- No contact/association, directly/indirectly the named parties
- Do not attend their home, work, school
- Do not attend the named address
- DNA order, No weapons – 5 years



Charges: Theft under x 2, FTC Probation x 3, FTC release order x 2

Disposition:

- Court appearance on October 28th
- Guilty plea to FTC Probation
- Time served; 10 days PSC enhanced to 15 days
- No further Probation
- All remaining charges were withdrawn

Disposition:

- Court appearance on October 28th
- Guilty pleas to; Theft under x 2
- Time served; 20 days PSC enhanced to 30 days
- 12 months' Probation
- Do not attend the named locations and addresses
- Remaining charges were withdrawn
- Has outstanding live charges before the court
- Trial scheduled for November 3rd



Charges: Assault – Spousal x 2, Theft under

Disposition:

- Court appearance on October 28th
- Guilty plea to assault
- Conditional discharge
- 2 year's Probation
- No contact with the named party
- Do not attend their home, work or school
- No weapons & DNA sample



Charges: FTC Probation x 13, Assault with a weapon x 2, Utter threats – BH, Possession for the purpose of trafficking – Meth x 2, Fentanyl x 2, Mischief, Unauthorized possession of a weapon x 2, FTC, Administer noxious thing, Possess prohibited weapon contrary to prohibition order

Disposition:

- Court appearance on October 28th
- Guilty pleas to; Utter threats - BH, Mischief, Possess for the purpose of trafficking Fentanyl
- 6 years' jail sentence for the CDSA charges
- 20 days of PSC enhanced to 30 days each for the threats & mischief charges concurrent to the sentence on the CDSA offence of six years
- All remaining charges were withdrawn as per the plea

Charge: Mischief – Domestic

Disposition:

- Court appearance on October 28th
- DAP completed
- Charge withdrawn



Charges: Sexual assault on a person under 16, Sexual interference

Disposition:

- Court appearance on October 28th
- Guilty plea to sexual interference
- Time served; 90 days PSC enhanced to 135 days jail
- 2 years' Probation
- No contact/communication in any way with named party
- Do not attend their home, work or school
- s. 110 weapons' Prohibition order – 10 years
- s. 161 order (schools, parks, employment, communicating via computer)
- 10 years, SOIRA order
- DNA sample



Charge: Criminal harassment

Disposition:

- Court appearance on October 31st, 2025
- Entered into a 12 months' Peace Bond
- Do not attend at any place the named party works or attends school
- Do not be within 50m of any place the named party lives
- Do not be within 10m of the named party
- Do not possess any weapons
- Charge withdrawn as per the Peace Bond
