Form 11 Releases:



Charges: Assault – Domestic, Mischief - Domestic
Released:

- Bail hearing on November 27th
- Released on a Form 11; Promise to pay \$250 if FTC
- Do not contact/communicate in any way with the named parties
- Don't attend where they live, work or attend school
- Do not possess any weapons
- Next court date is December 16th



Charges: B&E, FTC Probation x 2
Released:

- Bail hearing on November 27th
- Reside at named address
- Notify STPS within 24 hours of any change of address
- No contact/communication in any way with the named party
- Do not attend the named address
- Next court date is December 16th

Dispositions:



Charges: Impaired operation, Over 80 BAC, Novice driver - BAC above zero

Disposition:

- Court appearance on November 25th
- Guilty plea to Over 80 BAC
- \$2600 fine
- 12 months' driving Prohibition
- Remaining charges were withdrawn



Charge: Fail/Refuse to provide breath sample

Disposition:

- Court appearance on November 25th
- Guilty plea
- \$2600 fine
- 12 months' driving Prohibition



Charges: Impaired operation, Possession – Cocaine,
Drive commercial m/v – no licence

Disposition:

- Court appearance on November 25th
- Guilty plea to Impaired driving
- \$1,950 fine
- 18 months' driving Prohibition
- 80 hours of community service
- Remaining charges were withdrawn as per the resolution

Charges: FTC release order, FTC Probation

Disposition:

- Court appearance on November 25th
- All charges were withdrawn by the Crown
- NPI – No public interest



Charges: Arson – Disregard for human life, Arson, FTC Probation x 2,
Cause a disturbance

Disposition:

- Court appearance on November 25th
- Guilty pleas to; Arson, Cause a disturbance, FTC
- Sentenced to 12 months; 140 days PSC enhanced to 210 days; 155 days remaining to serve
- 3 years' Probation upon release
- Do not attend the named location/address
- Complete 40 hours community service
- Do not possess any incendiary devices
- No weapons
- Remaining charges were withdrawn by the Crown



Charge: Assault - Spousal

Disposition:

- Court appearance on November 25th
- Charge withdrawn by the Crown – NPI



Charges: FTC Probation, FTC release order

Disposition:

- Court appearance on November 25th
- Entered into a 6 months' CLPB
- No contact with named party
- Do not attend their place of residence, employment, or education
- Charges withdrawn as per the CLPB

Charges: Possession of property obtained by crime under \$5000 x 2,
Assault, FTC Probation
Possession for the purpose of trafficking - Fentanyl

Disposition:

- Court appearance on November 25th
- Guilty plea to FTC Probation – Sentenced to 10 days PSC
- Entered into a 12 months' CLPB re: Assault charge
- No contact with the named party
- Do not go anywhere they live, work or go to school
- Remain 15 meters away from the named party; No weapons
- Remanded into custody on remaining live charges
- Court appearance on November 26th
- All remaining charges were withdrawn by the Crown – NRPC



Charge: Utter threats

Disposition:

- Court appearance on November 25th
- Entered into a 15 months' CLPB, charge withdrawn
- No contact with the named party; not to be within 20m of them
- Do not attend any place they live, work or go to school
- Do not attend the named address; No Weapons



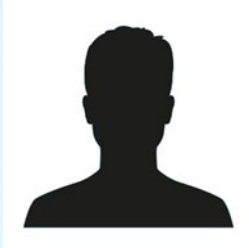
Charges: Utter death threat, Assault

Disposition:

- Court appearance on November 27th
- Entered into a 12 months' CLPB
- Charges withdrawn
- No contact, in any way with the named party
- Don't attend their home, work or school. Do not possess any weapons

Charges: Possession for the purpose of trafficking – Fentanyl,
Unauthorized possession of a weapon x 2, FTC release order x 4,
Possess property obtained by crime x 2

Disposition:

- Court appearance on November 28th
- Charges withdrawn by the Federal Crown
- Has live charges before the court; next court date is December 1st



Charge: Assault

Disposition:

- Court appearance on November 28th
- Diversion completed
- Charge stayed by the Crown



Charges: Utter death threat, FTC

Disposition:

- Court appearance on November 28th
- Entered into a 12 months' CLPB; charges withdrawn
- No contact/communication with the named parties
- Do not attend within 100m of their home, work, school
- Do not possess any weapons
