- Do not possess any weapons
- Next court date is February 3rd



Charges: Unlawfully in a dwelling, Assault, Mischief, Theft under \$5000
Released:

- Bail hearing on January 14th
- Released on a Form 11
- Promise to pay \$1000 if FTC
- No contact/communication with the named party
- Do not be within 25m of the named party
- Do not attend their home, work, or school
- Do not possess any weapons

- No contact with named party
- Do not attend any known place of residence, employment, or education of the named party

Charges: Theft under \$5000 x 8, Arson, FTC x 2

Disposition:

- Court appearance on January 13th
- Guilty pleas to; Theft under x 3, FTC, & guilty to the lesser offence of Mischief from the Arson charge
- Sentenced to time served
- 15 months' Probation
- Do not attend the named locations
- No contacts, non attendance locations to be set by Probation
- All remaining charges were withdrawn as per the resolution



Charge: False alarm of fire

Disposition:

- Court appearance on January 13th
- Charge withdrawn by the Crown
- Has outstanding live charges before the court



Charges: Assault, Assault police x 3, Mischief under x 2,

Disposition:

- No contact/communication with named party
- Remain 25m from the named party, their home, work, or school
- Remaining charges were withdrawn as per the resolution



Charges: Assault with a weapon x 2, Possess prohibited device,
Take m/v without consent

Disposition:

- Court appearance on January 14th
- Guilty pleas; Assault with a weapon, Possess prohibited weapon, Take m/v without consent
- Time served; 42 days PSC enhanced to 63 days

Disposition:

- Charges withdrawn as per the Peace Bond



Charge: Over 80 BAC

Disposition:

- Court appearance on January 16th
- Guilty plea to lesser charge of Careless driving – HTA
- \$1000 fine; 12 months' POA Probation
- Complete the Back on Track remedial program
- Do not operate a m/v except with a blood alcohol concentration of zero milligrams of alcohol per 100 ml of blood
- Carry a copy of the POA order at all times while operating a m/v and present it to police when D/L is requested
- Remaining charge was withdrawn as per the resolution



Charges: Utter threat BH, Mischief under \$5000

Disposition:

- Court appearance on January 16th
- Entered into a 12 months' Peace Bond
- Do not contact/communicate in any way with the named party
- Do not be within 15m of the named party
- Criminal charges were withdrawn as per the Peace Bond
