- Reside with surety at named address
- Do not contact/communicate in any way with the named party
- Do not be within 25m of them, their home, work, or school
- Do not possess any weapons
- Next court date is February 17th



Charges: Assault, Utter threat

Released:

- Bail hearing on January 22nd
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not contact/communicate in any way with the named parties
- Do not be within 50m of them, their home, work, school
- Do not be within 100m of the named address
- Do not possess any weapons
- Next court date is February 10th

Charges: Assault with a weapon, Theft under, Mischief, B&E, Assault police
Released:

- Bail hearing on January 23rd
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Reside at named address
- No contact/communication with the named parties
- Do not attend within 10m of them
- Do not attend where they live, work, attend school
- Do not attend the named address
- Do not attend the named location
- Do not possess any weapons
- Next court date is February 24th

Disposition:

- Court appearance on January 20th
- Guilty plea to Utter threat
- Conditional discharge, 12 months' Probation
- No contact with the named parties
- Do not attend their home, work, school
- No weapons
- Remaining charges were withdrawn



Charges: Utter death threat, Assault with a weapon, Mischief, FTC Probation

Disposition:

- Court appearance on January 20th
- Guilty pleas; Assault – Choke, Utter death threat
- Sentenced to 15 months jail, less 4 months PSC; 11 months remain
- 24 months' Probation
- No communication with the named party
- Do not attend any place they live, work or go
- Remain 10m away from the named party
- Reside at named address following sentence
- DNA sample
- No weapons – 10 years
- Remaining charges were withdrawn as per the resolution

Charges: Utter death threat, Use of credit card, Theft under \$5000 x 2, FTC

Disposition:

- Court appearance on January 20th
- Guilty pleas; Use of credit card, Theft under x 2, FTC
- Conditional discharge; Time served
- 12 months' Probation
- No contact/communication with the named parties
- Do not attend their residence, employment or place of education
- Do not attend the named address
- Remain out of the named location
- Remaining charges were withdrawn as per the resolution



Charges: Theft under, FTC Probation x 3, Use of credit card, Robbery

Disposition:

- Court appearance on January 20th
- Guilty pleas; Theft under from the Robbery charge, Utter threat & FTC
- Sentenced to 90 days and 3 years' Probation
- Do not contact/communicate in any way with the named party
- Do not be within 100m of their home, work, school
- 12 hours of community service a week to a total of 240 hours
- Do not possess any weapons
- Remaining charges were withdrawn as per the resolution



Charges: Robbery with intent to steal, Assault police, Resist arrest, Theft under \$5000

Disposition:

- Youth court appearance on January 21st
- Guilty pleas to assault, lesser to robbery & Resist arrest
- Conditional discharge; 18 months' Probation
- Do not attend at the named location
- No contact/communication with the named party
- Do not attend within 25m of them, their home, work, or school
- Do not possess any weapons
- Remaining charges were withdrawn

Charges: Impaired driving, Unauthorized possession of a prohibited weapon, Possess Schedule I – CDSA

Disposition:

- Court appearance on January 21st
- Guilty plea to Impaired driving
- \$1000 fine; 12 months' driving prohibition
- Remaining charges were withdrawn



Charges: Aggravated assault, Assault with a weapon, Assault – BH, B&E, Utter death threat

Disposition:

- Not criminally responsible – NCR hearing on January 21st
- Determined to be NCR on account of a mental disorder
- Entered into a Common Law Peace Bond
- No contact/communication with the named party
- Do not attend their home, work or school
- Do not possess any weapons
- Remanded to the Southwest Centre for Forensic Mental Health



Charge: Assault - Spousal

Disposition:

- Court appearance on January 23rd
- Entered into a 12 months' CLPB; Charge withdrawn
- No contact/association, directly/indirectly with the named party
- Don't attend within 25m of the named party
- Do not attend at any place of residence, employment or education
- Do not possess any weapons
- Successfully complete the Changing Ways Program
