Charges: Sexual assault on a person under 16 years, Sexual interference
Released:

- Bail hearing on January 5th
- Released on a Form 11; Promise to pay \$1000 if FTC
- Reside at named address. Remain in Ontario; Surrender passport.
- Do not be present in a residence where there is a child under 16 years
- Do not be in the company or communicate by any means with children under the age of 16 years
- Numerous no contacts & non attend locations incl. school grounds etc. where children under the age of 16 are present or will reasonably be
- Do not seek, obtain, or continue with any paid or unpaid activity that involves being in a position of trust or authority towards child under 16
- Do not possess any weapons
- Next court date is January 27th



Charge: Assault
Released:

- Bail hearing on January 6th
- Released on a Form 11; Promise to pay \$500 if FTC
- No contact/communication with the named party
- Do not be within 10m of them; Don't attend their home, work, school
- Do not attend the named address
- Do not possess any weapons
- Next court date is February 3rd



Charge: FTC release order
Released:

- Bail hearing on January 8th
- Released on a Form 11; Promise to pay \$5000 if FTC
- Reside at named address
- Remain in the residence at all time with **exceptions**
- Wear a GPS monitor and follow the program protocols
- Numerous no contacts/do not attend locations
- Do not possess any B&E tools
- Do not possess ID, bank card, cheque, unless it has been lawfully issued
- Next court date is February 3rd

- Do not possess any weapons
- Do not possess any drug paraphernalia incl. weigh scales, scales, more than one cellphone
- Next court date is February 2nd



Charges: Possess property under \$5000, Fraud under, FTC Probation x 4

Released:

- Bail hearing on January 8th
- Released on a Form 11; Promise to pay \$1000 if FTC
- Do not contact/communicate in any way with all named parties
- Do not be within 100m of them, their home, work, or school
- Do not attend named location
- Do not possess any ID, bank card, bank document, unless lawfully issued
- Do not possess any weapons
- Next court date is February 10th

Charges: STPS - Possession for purpose of trafficking x 3,
Unauthorized possession of a weapon x 2,
Possession of schedule I substance – Hydromorphone
OPP - Assault, B&E, Possession of CDSA

Disposition:

- Court appearance on January 6th
- Guilty pleas; Unauthorized possession of prohibited weapon, & B&E
- Suspended sentence; 12 months' Probation
- No contact/association with the named parties
- Do not attend the named locations/addresses
- DNA; s. 110 Order
- Has outstanding live charges before the court
- Breached on January 7th - Remanded into custody
- Video court appearance on January 12th



Charges: B&E, Possess property obtained by crime under \$5000 x 3, FTC x 3

Disposition:

- Suspended Sentence; 3 years' Probation
- No contact/communication with the named party

- Conditional discharge
- 12 months' Probation
- Do not attend the named locations/addresses
- 40 hours community service/counselling
- Do not possess incendiary devices **except** for 1 lighter
- Remaining charges were withdrawn as per the resolution
