- Do not contact/communicate with the named parties
- Don't attend the named locations
- Do not possess any weapons
- Next court date is March 31st



Charges: Possess property obtained by crime x 4, Theft under x under x 2,
Operate conveyance impaired, Operate conveyance prohibited, FTC

Released:

- Bail hearing on February 13th
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed,
- Reside at named address
- No contact/communication with all named parties
- Do not possess any ID or bank document/ bank card unless lawfully issued in name
- Next court date is March 31st

Disposition:

- Court appearance on February 9th

Charges: Point firearm x 2, Possess weapon for dangerous purpose x 2, Sexual exploitation x 2, Assault x 2, Assault with a weapon, Forcible confinement x 2

Disposition:

- Court appearance for scheduled trial on February 9th
- Entered guilty pleas for: Assault with a weapon, Possess a weapon for a dangerous purpose
- Time served; 7 days PSC enhanced to 10 days
- 3 years' Probation
- No contact/communication with the named party
- Don't attend their home, work, or school
- Don't be within 25m of the named party
- Don't attend the County of Elgin or the County of Middlesex after Feb 20th
- No weapons, DNA, Forfeiture order
- Remaining charges were withdrawn as per the joint submission



Charges: Sexual assault x 2

Disposition:

- Court appearance on February 9th
- Guilty plea to Sexual assault
- Community Service Order – CSO – 2 years less a day
- Wear a GPS and follow the program protocols
- 3 years' Probation
- No contact/communication in any way with the victim
- No weapons, DNA, 10 years SOIRA order

- Have a BAC of zero at all times while driving
- Ignition interlock with exceptions for Commercial m/v – work purposes
- Carry a copy of the probation order with driver's licence at all times while driving and surrender it to any peace officer
- Criminal charge & CDSA charge withdrawn
