**Form 11 Releases:**



**Charges:** Possession for the purpose of trafficking x 5, FTC x 5,  
Possess counterfeit money, Unauthorized possession of a weapon

**Disposition:**

- Bail hearing on February 4<sup>th</sup>
- Released on a Form 11; Promise to pay \$1000 if FTC
- Wear a GPS and follow the program protocols
- Reside at named address
- Remain in the residence at all times with **exceptions**
- Do not go to any place where the named parties live, work, attend school
- Do not contact/communicate with them
- Do not possess any weapons
- Possess only one cell phone or cell device
- Do not possess any drug trafficking paraphernalia
- Next court date is March 30<sup>th</sup>



**Charges:** Aylmer PS - Possess schedule I substance x 2, FTC, Theft under x 2  
**STPS** - Theft under x 5, FTC x 3, Unlawful use of credit card,  
Possess property obtained by crime under \$5000

**Released:**

- Bail hearing on February 4<sup>th</sup>
- Released on a Form 11; Promise to pay \$1000 if FTC
- Wear a GPS and follow the program protocols
- Reside named address
- Numerous no contact/communication and do not attend locations
- Next court date is March 2<sup>nd</sup>
