Charges: Criminal harassment, B&E

Released:

- Bail hearing on February 23rd
- Released on a Form 11; Promise to pay \$1000 if FTC
- Wear a GPS and follow the program protocols
- Report to the John Howard Society as directed
- Reside at named address
- Remain in residence 24 hours a day with
- Do not contact/communicate with the named parties
- Don't be within 100m of their home, work, school
- Do not be within 500m of the named address
- Do not possess any weapons
- Next court date is March 17th



Charges: Utter threat, Assault police, FTC

Released:

- Bail hearing on February 24th
- Released on a Form 11; Promise to pay \$250 if FTC
- Do not contact/communicate in any way the named party
- Do not attend any place the named party lives, works, attends school
- Do not possess any weapons
- Next court date is March 31st

Charges: OPP - Possess Cocaine & Fentanyl, Assault – Spousal x 2, Mischief, Assault with a weapon – Spousal, Assault, Theft under, Operate a conveyance impaired, Assault with a weapon, Possess property under \$5000 x 2, FTC, Mischief, Possess weapon dangerous, Forcible confinement

STPS - Forcible confinement, Assault with a weapon x 2, FTC x 2, Operate a conveyance while prohibited, Operate a Conveyance impaired
