**Form 11 Releases:**



**Charges: OPP - Abduction**  
**STPS - FTC**

**Released:**

- Bail hearing on March 16<sup>th</sup>
- Released on a Form 11; Promise to pay \$5000 if FTC
- Reside at either named addresses
- Remain in the Province of Ontario
- Do not reapply for a passport or travel permit/document
- No contact/communication in any way with the named parties
- Do not be within 25m of their home, work, school
- Do not attend within 10 km of the named address
- No weapons
- Next court date is April 16<sup>th</sup>

**Dispositions:**



**Charge:** Possess schedule I - Hydromorphone

**Disposition:**

- Court appearance on March 16<sup>th</sup>
- Charge withdrawn by the Crown
- No public interest – NPI
- Has live charges before the court
- Next court date is March 31<sup>st</sup>



**Charges:** Possess schedule I substance x 2 – Cocaine, Oxycodone

**Disposition:**

- Court appearance on March 16<sup>th</sup>
- Direct Accountability Program – DAP complete
- Charge withdrawn



**Charges:** Assault – BH x 7, Assault – Spousal x 10, Utter death threat

**Disposition:**

- Court appearance on March 17<sup>th</sup>
- Entered into a 15 months' Common Law Peace Bond – CLPB
- All charges were withdrawn
- No contact/communication with the named party
- Do not attend at any place they live, work or go to school
- Do not be within 25m of the person
- Do not possess any weapons

**Charges:** Theft under \$5000 x 7, FTC Probation x 8

**Disposition:**

- Court appearance on March 17<sup>th</sup>
- Guilty pleas; Theft under x 4, & FTC Probation x 2
- Sentenced to 162 days; 72 days PSC enhanced to 108 days
- 3 years' Probation
- No contact with the named party
- Do not attend their home, work, school
- Do not attend the named locations
- Remaining charges were withdrawn as per the resolution



**Charges:** Assault, Unlawfully in a dwelling, Disqualified drive, B&E, Theft over x 2, Theft under, Trespass at night, FTC x 4, FTC Probation x 3, Mischief under, Drive while suspended - HTA

**Disposition:**

- Court appearance on March 17<sup>th</sup>
- Guilty pleas; Unlawfully in a dwelling, Drive disqualified, Theft over x 2, Mischief under, B&E, FTC x 3
- 25 months' global Penitentiary sentence
- 10 years' driving Prohibition



**Charges:** Possession of property obtained by crime over \$5000 x 2

**Disposition:**

- Court appearance on March 17<sup>th</sup>
- Charges withdrawn by the Crown

**Charges:** Sexual assault, Utter threat, FTC Probation, FTC

**Disposition:**

- Court appearance on March 17<sup>th</sup>
- Charges withdrawn by the Crown
- No reasonable prospect of conviction – NRPC
- Remaining charges were withdrawn on March 18<sup>th</sup>



**Charge:** Possess schedule I substance for trafficking – Cocaine

**Disposition:**

- Court appearance on March 17<sup>th</sup>
- Charge withdrawn



**Charge:** Possess schedule I substance for trafficking – Cocaine

**Disposition:**

- Court appearance on March 17<sup>th</sup>
- Guilty plea
- 12 months' Conditional Sentence Order – CSO
- Reside at named address
- Wear a GPS & follow the program protocols
- Forfeiture order

**Charge:** Possession of schedule II substance – Trafficking Fentanyl

**Disposition:**

- Court appearance on March 18<sup>th</sup>
- CDSA charge withdrawn by the Crown
- Has outstanding live STPS charges
- Next court date is March 24<sup>th</sup>



**Charge:** Theft under \$5000

**Disposition:**

- Court appearance on March 18<sup>th</sup>
- Charge withdrawn by the Crown



**Charges:** Impaired operation, Fail to remain – HTA

**Disposition:**

- Court appearance on March 18<sup>th</sup>
- Guilty plea to Impaired operation
- \$1200 fine; 12 months' Driving Prohibition
