Charge: Assault

Released:

- Bail hearing on March 2nd
- Released on a Form 11; Promise to pay \$200 if FTC
- Next court date is March 10th



Charges: Assault, FTC Undertaking

Released:

- Bail hearing on March 4th
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not contact/communicate in any way with the named parties
- Do not be within 100m of the named parties or named addresses
- Do not possess any weapons
- Next court date is March 17th



Charges: STPS - B&E, Assault x 2, Assault with a weapon, Assault - Choking
Theft under, FTC Probation x 2

OPP - FTC, Breach Probation

Released:

- Bail hearing on March 4th
- Released on a Form 11; Promise to pay \$1500 if FTC
- Wear a GPS and follow the program protocols
- Reside at named address
- Remain in residence daily b/w 10pm and 7am
- Numerous no contacts, do not attend locations
- No weapons
- Next court date is April 21st
- Breached on March 5th - OPP
- Bail hearing on March 6th - Released on a Form 11
- Next court date is April 21st

Charges: Theft under, FTC Probation x 6, Use credit card x 4,
Possess property obtained by crime under \$5000

Disposition:

- Bail hearing on March 4th
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Do not contact/communicate in any way with the named party
- Do not attend the named location
- Do not possess any banking document/card unless lawfully issued
- Next court date is March 17th



Charges: Sexual assault, Luring under age 18 by telecommunication,
Sexual exploitation, Communicate under 18 years for sex purposes

Released:

- Bail hearing on March 6th
- Released on a Form 11; Promise to pay \$1000 if FTC
- Do not contact/communicate in any way with the named party
- Do not be within 50m of their home, work, school
- Do not be in the company/communicate w/males under the age of 16
- Do not seek, obtain, or continue with paid or unpaid activity that involves being in a position of trust or authority of anyone under the age of 16
- Do not possess any weapons
- Next court date is April 7th


Dispositions:



Charges: Obstruct police, Possess property obtained by crime under \$5000, FTC x 3, FTC Probation

Disposition:

- Court appearance on March 3rd
- Guilty pleas; Obstruct police, FTC
- Sentenced; 1 day deemed served, 40 days PSC enhanced to 60 days
- DNA sample
- All remaining charges were withdrawn as per the resolution



Charge: Assault - Spousal

Disposition:

- Court appearance on March 3rd
- Entered into a 9 months' Common Law Peace Bond - CLPB
- No contact/communication, in any way with the named party
- Do not attend their home, work, or school
- Charge withdrawn



Charges: Utter threats – BH, Criminal harassment

Disposition:

- Court appearance on March 3rd
- Charges withdrawn by the Crown
- Withdrawn as part of a resolution with another jurisdiction



Charge: Impaired operation

Disposition:

- Court appearance on March 3rd
- Guilty plea to Impaired operation
- \$1500 fine, 12 months' driving Prohibition

Charges: FTC probation, FTC release order x 2

Disposition:

- Court appearance on March 3rd
- Guilty pleas; FTC x 2
- 1 day deemed served; 20 days PSC enhanced to 30
- Has live outstanding charges before the court
- Released on a Form 11 on March 4th



Charge: FTC Probation

Disposition:

- Elgin Therapeutic Court
- Guilty plea to FTC Probation to enter the ETC program
- Suspended sentence; 12 months' Probation
- Next court date is April 1st



Charges: Possess property over \$5000, Fail to stop police,
Drive m/v – no licence

Disposition:

- Youth court appearance on March 4th
- Guilty plea to Possess property over \$5000
- 12 months' Probation
- 50 hours of Community Service
- Remaining charges were withdrawn
- Remains in custody on other agency charges



Charge: Assault

Disposition:

- Youth court appearance on March 4th
- Entered into a 12 months' CLPB
- No contact/communication in any way with the named party
- Do not attend their home, work, school
- Do not possess any weapons

Charges: Assault – BH, Assault

Disposition:

- Youth court appearance on March 4th
- Guilty plea to Assault
- 18 months' Probation
- No contact/communication with the named parties
- Don't attend where they live or work
- Do not possess any weapons
- DNA



Charges: Sexual Assault x 2

Disposition:

- Court appearance on March 4th
- Guilty plea to one count of Sexual assault
- 18 months' Conditional Sentence Order
- 9 months house arrest, 9 months curfew
- 3 years' Probation
- Reside at named address
- No alcohol or cannabis/intoxicating substances
- No contact/communication with the named party
- Do not attend their home, work, school
- 10 years SOIRA, DNA, No weapons



Charge: Theft under \$5000

Disposition:

- Court on March 6th
- Charge withdrawn by the Crown
