**Form 11 Releases:**



**Charges:** Utter death threat, FTC, Theft under \$5000

**Released:**

- Bail hearing on March 7<sup>th</sup>
- Released on a Form 11
- Do not contact/communicate in any way with the named party
- Do not possess any weapons
- Breached on March 8<sup>th</sup>
- Remanded into custody; Next court date is March 16<sup>th</sup>



**Charges:** Traffic in schedule I substance x 3, Possess substance in schedule I  
For purpose of trafficking x 3

**Released:**

- Bail hearing on March 9<sup>th</sup>
- Released on a Form 11; Promise to pay \$10,000 if FTC
- Reside at named address
- Surrender passport with STPS
- Do not contact/communicate with all named parties
- Don't attend the named locations / addresses
- Do not possess any weapons
- Next court date is April 13<sup>th</sup>



**Charges:** Aggravated assault, Theft under, FTC Probation

**Released:**

- Bail hearing on March 9<sup>th</sup>
- Released on a Form 11; Promise to pay \$750 if FTC
- Reside at named address
- Do not contact/communicate with all named parties
- Do not be within 25m of the named parties, their home, work, or school
- Do not possess any weapons
- Next court date is April 14<sup>th</sup>

**Charges:** FTC Probation x 2

**Released:**

- Bail hearing on March 11<sup>th</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not attend within 100m of the named location
- Wear a GPS and follow the program protocols
- Next court date is April 14<sup>th</sup>



**Charges:** Theft under x 6, FTC x 3

**Released:**

- Bail hearing on March 12<sup>th</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Bail hearing FTC charge withdrawn by the Crown
- Wear a GPS and follow the program protocols
- Remain in residence, 24 hours a day with exceptions
- Do not be within 10m of the named locations
- Next court date is March 24<sup>th</sup>



**Charges:** Harassing communication, FTC

**Released:**

- Bail hearing on March 12<sup>th</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Do not contact/communicate with the named party
- Do not be within 100m of their home, work or school,
- Do not possess any weapons
- Next court date is March 31<sup>st</sup>

**Charge:** Mischief – in relation to data

**Disposition:**

- Court appearance on March 10<sup>th</sup>
- Restitution complete
- Charge withdrawn



**Charge:** Assault

**Disposition:**

- Court appearance on March 10<sup>th</sup>
- Entered into a 12 months' CLPB
- Do not associate directly/indirectly with the named party
- Do not attend their home, work, or school
- Charge withdrawn as per the CLPB



**Charges:** FTC Probation, Dangerous operation, fail to stop-police, Drive wile under suspension, Fail to surrender insurance, permit, & licence

**Disposition:**

- Court appearance on March 10<sup>th</sup>
- Charges withdrawn by the Crown
- No reasonable prospect of conviction
- One outstanding charge before the court – Next court date is Apr 7<sup>th</sup>



**Charge:** Assault

**Disposition:**

- Court appearance on March 10<sup>th</sup>
- Guilty plea to assault
- Conditional Discharge; 12 months' Probation
- Do not contact/communication with the named parties
- Do not attend their home, work, or school
- Do not attend the named address
- No weapons

**Charges:** FTC Undertaking x 2, FTC Probation

**Disposition:**

- Court appearance on March 10<sup>th</sup>
- Guilty plea to FTC undertaking
- Conditional sentence
- 12 months' Probation with terms; reporting; reside where approved;
- No contact with named party
- Do not attend their home, work or school
- Do not drink alcohol except within their home
- Remaining charges were withdrawn as per the resolution



**Charges:** B&E x 2, FTC Probation x 5, Theft under x 2, Obstruct, FTC

**Disposition:**

- Court appearance on March 10<sup>th</sup>
- Guilty pleas; Theft under, FTC Probation, FTC
- Guilty plea to lesser offence of Trespass at night from B&E
- Suspended sentence
- 12 months' Probation
- Do not attend the named location
- Remaining charges were withdrawn as per the resolution



**Charges:** **OPP** – Utter threat, Harassing phone calls, FTC x 4

**STPS** – Assault, unlawfully in a dwelling, FTC x 3

**Disposition:**

- Court appearance on March 10<sup>th</sup>
- Guilty pleas; Utter threat, Assault, FTC x 3
- Suspended sentence; 6 months' Conditional sentence - house arrest
- Reside at named address
- GPS - to remain out of St. Thomas
- 18 months' Probation
- No contact/communication with the named parties
- DNA and No weapons for 10 years
