- Do not attend the named location. 40 hours community service



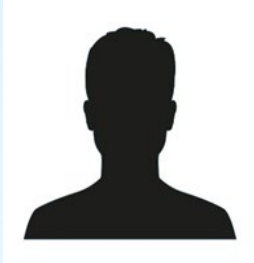
