Charges: Possession for the purpose of trafficking – Fentanyl & Hydromorph

Disposition:

- Court appearance on March 30th
- Guilty plea to one count
- Sentenced to 5 years, less time served; 3.6 years remaining
- DNA, No weapons, Forfeiture order



Charges: Possess schedule I substance for Trafficking x 2 – Cocaine & Fentanyl

Disposition:

- Court appearance on March 31st
- Charges withdrawn by the Crown



Charges: Mischief under x 2, Indecent act, Possess property over, FTC

Disposition:

- Court appearance on March 31st
- Guilty plea; Mischief under
- Time served; 22 days PSC equal to 33 days jail
- 12 months Probation; 80 hours of community service
- No contact orders in place
- Do not attend the named locations
- Remaining charges were withdrawn

Charges: Assault x 3, Utter threats x 2, False alarm, FTC

Disposition:

- Court appearance on March 31st
- Found guilty after trial – Utter death threat, & FTC
- Conditional discharge; 12 months' Probation
- No contact orders in place, do not attend named locations



Charges: Impaired operation, Over 80 BAC, Dangerous operation

Disposition:

- Court appearance on March 31st
- Guilty plea to Impaired driving
- \$3000 fine, 12 months' driving Prohibition
- All remaining charges were withdrawn



Charges: Utter threat BH, Mischief over

Disposition:

- Court appearance on April 1st
- Guilty plea to both charges
- Conditional Discharge plus 15 months' Probation
- Do not attend the named address
- 40 hours community service

Charges: Utter threats, Assault, Assault with a weapon

Disposition:

- Court appearance on April 1st
- Entered into a 12 months' CLPB
- No contact with the victims
- Charges withdrawn



Charges: Assault with a weapon, Utter death threat, Theft under x 2, FTC

Disposition:

- Court appearance on April 2nd
- Guilty plea to FTC
- Sentenced to time served, 26 days PSC enhanced to 39 days
- 12 months' Probation; Usual conditions
- No contact orders; Do not attend the named locations
- No weapons; Remaining charges were withdrawn



Charges: Theft under, FTC Probation x 3

Disposition:

- Court appearance for guilty plea on April 2nd
- Sentenced to time served on those charges
- Released from custody
