Form 11 Releases:



Charges: Breach Probation x 4, FTC x 2

Released:

- Bail hearing on April 27th
- Released on a Form 11; Promise to pay \$1000 if FTC
- Wear a GPS and follow the program protocols
- Do not operate or have care or control of a m/v
- Do not occupy the driver's seat of a m/v
- Do not attend within 100m of the named address
- Next court date is May 5th



Charges: Assault, Assault – Choke, Utter threat, Mischief under, FTC,
Operate a conveyance dangerous, Over 80 - BAC

Released:

- Bail hearing on April 27th
- Released on a Form 11; Promise to pay \$1000 if FTC
- Reside at the named address
- No contact with/Do not attend the location of the named parties
- Next court date is May 19th



Charges: Theft under x 4, Possess property by crime under, FTC,
Assault police x 2

Released:

- Bail hearing on April 30th
- Released on a Form 11; Promise to pay \$200 if FTC
- Reside at the named address
- No contact with/Do not attend location the locations of the named party
- No weapons
- Next court date is May 5th

Charges: Operation while prohibited x 2, FTC undertaking

Released:

- Bail hearing on May 1st
- Released on a Form 11; Promise to pay \$1000 if FTC
- Reside at the named address
- Notify STPS within 24 hours of any address change
- Do not occupy the driver's seat of a m/v
- Next court date is May 26th



Charges: Possess schedule I substance x 3, FTC Probation

Released:

- Bail hearing on May 1st
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not attend with 50m of the named address
- Next court date is June 11th

Dispositions:



Charges: Criminal harassment, Mischief, Utter threat

Disposition:

- Court appearance on April 28th
- Entered into a 3 years' CLPB
- No contact with/Do not attend locations
- Charges withdrawn

Charges: Assault, Assault with a weapon, Sexual assault

Disposition:

- Court appearance on April 28th
- Charges withdrawn by the Crown
- No public interest



Charges: Impaired operation, Over 80 BAC

Disposition:

- Court appearance on April 28th
- Guilty plea; Over 80 BAC
- \$2500 fine
- 12 months' driving prohibition



Charges: Utter death threat x 2, Utter threats – BH x 2

Disposition:

- Court appearance on April 28th
- Charges withdrawn by the Crown - NPI



Charges: Assault, Take m/v without consent, Mischief

Disposition:

- Court appearance on April 28th
- Guilty pleas; Take m/v without consent, & Assault
- Absolute discharge for Take m/v without consent
- Conditional discharge plus 12 months' Probation for assault
- No contact order/Do not attend location
- No weapons

Charges: Assault, Non-consensual distribution of intimate images, FTC x 2,
Possess schedule I substance - Cocaine, Possess property under \$5000

Disposition:

- Court appearance on April 28th
- Guilty plea to lesser charge; Growing excess amount of marihuana plants
- 9 months' Conditional sentence, plus Probation
- Fine; \$1500 a year, for 15 years
- DNA, No weapons, & Forfeiture order



Charges: Assault, S. 810 Peace Bond

Disposition:

- Court appearance on April 28th
- Entered into a 12 months' Peace Bond
- No contact with/Do not attend location of the named party
- No weapons, charges withdrawn



Charge: FTC Probation

Disposition:

- Court appearance on April 28th
- Guilty plea, FTC
- \$650 fine, no further Probation



Charge: Over 80 BAC

Disposition:

- Court appearance on May 1st
- Guilty plea to lesser offence of Careless driving
- \$1000 fine, 12 months' POA Probation
- Do not operate a m/v with a BAC above zero

- Counselling, No weapons

- Guilty plea to lesser offence of Careless driving
- \$1000 fine
- Criminal charge withdrawn
